Qualified Entrant and Entry

- A qualified Entrant ("Entrant") is 19 years of age or older and has earned an ("entry") by complying with the "**Contest Details for BC Day Slot Tournament**" and "**How to Qualify for BC Day Slot Tournament**" sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Chances Maple Ridge and its subsidiaries and affiliates, and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address;

How to Qualify for BC Day Slot Tournament

Qualifying Rounds - Details

- This Slot Tournament is open to all Encore Rewards Members. Sign up is free at the cash cage.
- The BC Day Slot Tournament will be available in two sessions:
 - Morning: 11AM – 2PM
 - Evening: 3PM – 6PM
- Players that are interested in participating must insert their encore card to any slot machine to launch the EBS Slot Tournament. ETGs are not included in this promotion.
- The tournament which will be programmed to activate when a player sits at the bank and inserts their encore card.
- Qualified players can participate anytime during the two sessions.
- Entrants will be given **one (1) entry per session, for a maximum of two (2) entries during the promotional day.**

“Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to “BD DAY” c/o Chances Maple Ridge.
