- Entrant(s) must be playing on any Electronic Table Games Terminal with their Encore Rewards card inserted to earn points for the U-Spins.

1. Earning Entry through Electronic Table Games Terminal Play

2. "Self-Addressed Stamped Envelope" Entry ("SASE Entry")
