Qualified Entrant and Entry

- A qualified Entrant ("Entrant") is 19 years of age or older and has earned an ("entry") by complying with the "**Contest Details for Mystery Thursday**" and "**How to Qualify for Mystery Thursday**" sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Chances Maple Ridge and its subsidiaries and affiliates, and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address;

Contest Details for Mystery Thursday

- The Contest Period runs from **10:00AM PT Tuesday, September 1, 2026, to 8:00PM PT Thursday, December 21, 2026**.
- Encore Rewards Members will be able to earn ballots into the draw every day during opening ours throughout the promotional period.
 - Each weeks draws will occur on Thursdays at 8PM with special draws occurring on the last Thursday of each month.
 - Special Draw Dates: September 24, October 29, November 26 & December 31.
- The participating site will be Chances Maple Ridge.

Prizing for Mystery Thursday

- Encore Rewards Members who visit the Cash Cage on any Thursday during the promotional period will be eligible to receive a \$10 Bonus Play Voucher as well as a ballot into the prize draws.
- Bonus Play Vouchers will be valid on the following day for a seven (7) day period only.

How to Qualify for Mystery Thursday

There are **three (3) ways** to enter the **draws**: Earning Entry through Slot Play, Visiting the Cash Cage on Thursdays, or with a “Self-Addressed-Stamped Envelope” alternative.

1. Earning Entry through Slot Play

- Entrant(s) may earn a ballot into the weekly Thursday Draw by earning 250 Encore Rewards Points every day during the promotional period.
- Maximum ten (10) entry per Entrant can be earned this way each day.
- Entrants must be an Encore Rewards Member. Sign up is free at the Cash Cage.

2. Earning Entry through Cash Cage on Thursday

- Entrant(s) may earn a ballot into the weekly Thursday Draw by visiting the Cash Cage on Thursdays during the promotional period.
- Maximum one (1) entry per Entrant can be earned this way each week.
- Entrants must be an Encore Rewards Member. Sign up is free at the Cash Cage.

3. “Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

No purchase necessary. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

Ballot Tracking and Entry for Mystery Thursdays

- Ballots removed from Cash Cage must be recorded on the “Ballot Inventory Tracking” spreadsheet.
- Team members must indicate the number of ballots removed, the date removed, the corresponding serial numbers, and the updated ending balance, along with their department, initials, and GAWM.
- Earned ballot(s) must be deposited into the assigned draw barrel prior to the start of the draw.
- 4. An eligible ballot will include Entrant’s First Name, Last Name and Encore Rewards Number. If anyone (1) of these three (3) fields is not included, the ballot will be deemed invalid and a redraw will occur. Any customer that enters with ‘SASE’ needs to fill out the ballot per eligible ballot instructions and will need to qualify as per the Qualified Entrant and Entry to win.

- Selected entrant names ("Drawn Entrant") will be announced via the public address (PA) system.
- Drawn Entrants must identify themselves to a designated representative within two (2) minutes of the first announcement to be confirmed as the winner.
- If a Drawn Entrant does not claim their prize within the allotted time, unlimited redraws will occur until a winner is found.
- Every redraw must yield a unique name; repeat names will be disqualified and discarded.

Weekly Draws (8:00 PM):

- One (1) entrant selected at random from all eligible ballots received within the weekly qualifying barrel.
